Proof of Insurance and Endorsements Guidelines

**You agree to maintain personal general liability insurance and/or business general liability insurance with minimum limits of \$1,000,000 per occurrence.** If any of the Equipment is to be used for a commercial purpose or is otherwise designated as "customer insured," You agree to also maintain Rented Equipment Physical Damage or Loss insurance on an all-risks basis for the full replacement cost of the Equipment (including without limitation, all risks of loss or damage covered by the standard extended coverage endorsement) with such deductibles, if any, as may be acceptable to Lewistown Rental LLC, Hi-Line Rental LLC, Glasgow Rental LLC, and Golden Triangle Rental LLC (LR/HR/GR/GTR). Such insurance shall cover all operations and contractual obligations, as well as any and all damage or liability arising in connection with the handling, transportation, maintenance, operation, use or possession of the Equipment during the Term, and shall name LR/HR/GR/GTR as an additional insured and loss payee on a "closed clause" basis. All such insurance shall be primary, without any self-insured retention, and shall waive subrogation against LR/HR/GR/GTR. You agree to provide LR/HR/GR/GTR with copies of the proper endorsements for the above coverages, specifying that they will not be cancelled during the term.
